

#### **General Entry Information**

A dog will earn an AKC Farm Dog Certificate FDC) by qualifying under two different judges at two separate licensed or member Farm Dog events.

A dog will earn an AKC Herding Instinct Certificate (HIC) by qualifying under two different judges at two separate licensed or member Herding Instinct Tests.

Over this one day, with the judges and the divisions available, a dog can earn both an FDC and an HIC.

Entry fees: For each entry, \$45 for Farm Dog; \$45 for Instinct Test.

For online entries, instructions will show on the online entry form as your total is tabulated.
